SOCIAL PRESCRIBING IN THE DUDLEY BOROUGH



We reached out to Social Prescribers from different areas within the borough so they could share their views about their service.

We found a wide range of socioeconomic barriers for local people to access services that can help them. Social Prescribers provided suggestions to improve the experiences of the community.

RECURRING THEMES

(Q: What are some recurring themes in your area that you would like to highlight?)

- Further support for talking therapies
- Issues with GP access and making appointments
- Cost of living and housing crisis
- Transport costs and services, mobility difficulties
- Gaps in community services for working age people
- Social Isolation, anxiety and poor mental health
- Social purpose (such as) loss of health and retirement
- Young people require a stronger voice about their services and the decisions that are made



SUGGESTIONS FOR SERVICES THE COMMUNITY MAY BENEFIT FROM:

(Q: Have you identified any services that you believe the community could benefit from if they were provided?)

- More services for young people, social interactions and youth clubs
- Opportunities for free exercise and sport
- Easily available volunteering opportunities
- More befriending opportunities for speakers of various languages
- Digital inclusion projects
- Secondary care mental health support groups
- A bridge between the gap of referral and diagnosis where the wait is long such as mental health, CAMHs, autism and ADHD



80% of respondents reported receiving inappropriate referrals that require follow-up replies to ensure clients receive the right service.

HOW CAN HEALTHWATCH DUDLEY SUPPORT THESE VIEWS?

- Work closely with local authorities, healthcare providers and community organisations to ensure that people's views are prioritised and put into action
- Work actively with local initiative boards to support the implementation of services based on community input
- Continuously gather feedback from the community and share it with relevant stakeholders, facilitating positive changes
- Create and provide resources to help individuals navigate available services more easily
